#### Dear Landowner:

We write to inform you that the tree clearing project for Drainage District No. 37 (DD37) in Clay County will commence very soon, as early as this week. You own land abutting/adjacent to the ditch in the area where work will be taking place. Please read through the information below and contact us if you have any questions or concerns.

#### Contract:

Bids were opened for the Drainage District No. 37 (DD37) tree clearing project on September 29<sup>th</sup>, 2022. The contract was awarded for the Bid Alternate to the low bidder Reutzel Excavating, Inc. in the amount of **\$828,376.50**. The contract completion date is June 1, 2024.

#### **Project Description:**

In general, the work consists of clearing trees growing within and adjacent to the channel of the Main Open Ditch of DD37, along with the construction of two (2) permanent access lanes on the west side of 300<sup>th</sup> Ave. The intent is to remove the trees that are currently a problem, those that will be a problem soon, and those that are necessary in order for equipment access and navigation. Herbicide will be applied to the stumps of trees that are sawn. In general, the extent of planned tree clearing is 75 feet from the center of the channel. However, no more trees will be removed than necessary as part of this project. If you wish to have additional trees removed by the contractor you will need to make separate arrangements with them directly, at your expense.

#### Fencing:

We note that there are existing fences in place along the ditch which will need to be removed in order to complete the work. If you have fences that are actively used to keep in animals, or if you have any other concerns or specific requests, we ask that you contact the contractor for coordination. Otherwise, best professional judgment will be used and fences in very poor condition will be removed and buried.

### Access/Work Limits/Damages:

The contractor will need to have access to the ditch at the several road crossings along its length. See the enclosed map for anticipated access locations. If you have concerns, please contact the contractor, or myself. Work limits are what is reasonably necessary to complete the work. Every effort will be made to minimize crop damages. However, if crop damages occur, they will be measured and documented, and reimbursed as part of the completion hearing once construction is completed. We recommend that you plant crops as you normally would. Please note that damages within the 150 ft ditch right-of-way are not eligible for reimbursement, although this would apply to very little, if any, area.


